

ADDENDUM NO. 2

DILLSBORO COMMUNITY PARK BASKETBALL & PICKLEBALL COURTS PROJECT

DILLSBORO, INDIANA

Bidders are hereby notified of the following information, which is made as part of the contract documents for the above referenced project:

1. Bid Bond, Performance Bond & Payment Bond:

A Bid Bond in the amount of 5% of the contractor's bid is required. The bid form item has been removed. The successful bidder will be required to furnish a Performance Bond and a Payment Bond, each in the amount of 100% of the contractor price, within 10 days of Notice of Award. Bidders shall include all costs associated with furnishing the required bond within their base bid price.

2. Bid Alternatives:

The work identified on Sheet C2.0 as "*Alternative Bid Option #2: 4' tall black vinyl fence between each pickle ball court*" is included in the bid form as "*Alternative Bid 1*", bid this item as specified in the bid form;

The work identified on Sheet C2.0 as "*Alternate Bid Option #3: Relocation of Existing Flush Hydrant Per Direction of the Owner*" is not included on the bid form. The owner is removing this item from the scope and this work should be disregarded for purposes of this project.

The Bid Form included Alternate Bid 2, item #15, "*Water Fountain*", and item #16 "*Water Fountain Line (to extend service line to feed water fountain)*" this item has been removed. The owner will not be proceeding with this scope of work.

A revised Bid Form is attached to this addendum and shall be utilized in the submittal of all bids.

3. Bid Form Notes:

Note #2 of the bid form has been revised to permit "... *Excess waste material may be dumped at the Town provided dumps site during normal operating hours, Monday through Friday 7:30 AM to 4:00 PM at the waste water treatment plant, 13824 Spangler Road, Dillsboro, IN, 47018.*"

Note #7 regarding alternate bid 2 has been removed, bidders are no longer asked to price this alternative.

A footer was added to the bottom of the bid form specifying the required documents to be included with the bid, bidder should check boxes acknowledging the requirements and provide additional documentation as required.

The following documents must be submitted with this Bid:


Failure to include any required documentation may result in a non-responsive bid.
