September 12, 2022

The regular monthly meeting of the Dillsboro Town Council was opened by President, Tom Wafford, with the pledge to the flag on September 12, 2022 at 6:00 p.m.

Prayer was given by Pastor Steve O'Brien from the CARE Team.

Council members present: Mary Lou Powers, Tom Wafford, Doug Baker, Becky Fryman and Tim Benning. Attorney present: John Watson. Election Council Candidates present: Charlie Caldwell and Jacob Kohorst.

The minutes of the August 22, 2022 were approved by CM Baker. Seconded by CM Powers. Motion carried.

<u>Clerk-Treasurer – Rita Stevens</u>

- Additional Appropriations Resolution 2022-9-1. General for \$50,000.00. Local Road & Street for \$2,500.00. CM Baker made a motion to approve the additional appropriations. Seconded by CM Powers. Motion carried.
- CT Stevens asked for any open comments for the 2023 Public Hearing for the budget. No comments. Adoption Meeting will be the next council meeting on Monday, October 10.

Fire Department - Tim Heitmeyer

- o Kyle Cleeter is taking the water school for his license.
- O Dave O'Mara quotes. #1 Inlet in front of Legion for \$7,250.00 #2 3 patches on North & Main Streets for \$4,250.00. 3# Patch on SR 262 approximately 800 SF is \$37,900 from water leak damage. After discussion. CM Fryman made a motion to approve all 3 quotes and paid from Riverboat. Seconded by CM Benning. Motion carried.

CM Baker asked if the utility workers could weedeat across from the green space on the corner of North & Front Streets by the Buck property. Bauer said he would get it done.

- Annexation Contacted Rhonda Cook and will be drawing up a working agreement.
- Dearborn County Foundation Endowment Matching Program. CM Powers made a motion for \$5,000.00 to the Quality of Life. Paid from Riverboat. Seconded by CM Baker. Motion carried.
- o Slone Request for Wavier on driveway and parking areas to use gravel. Technical Review is September 19. Town ordinance states asphalt, concrete, brick or concrete pavers or equivalent material. Must provide a durable and dust-free surface. Greco will attend.
- o Beautification of Dillsboro Business Entity Report. Permission to legally dissolve. Greco will just let it go away.
- Dillsboro Disaster & Emergency Response Plan Will meet with Police and Fire Departments, EMS, DCEMA and other community leaders to discuss and finalize.
