July 24, 2023

The regular monthly meeting of the Dillsboro Town Council was opened by President, Doug Baker, with the pledge to the flag on July 24, 2023 at 6:00 p.m.

Council members present: Doug Baker, Becky Fryman, Tim Benning, Charlie Caldwell and Jamie Craig. Attorney present: John Watson.

The minutes of the regular meeting on July 10, 2023 were approved by CM Benning. Seconded by CM Caldwell. Motion carried.

<u>Clerk-Treasurer – Rita Stevens</u> – nothing to report. Fund & Appropriation reports were given to council.

# <u>Utility Department – Matt Bauer</u>

- Heating & Air Conditioning in the Utility Maintenance Shop. Quotes from Showcase of \$6,900.00 and Stutler's of \$5,950.00. Bauer contacted 2 other businesses but no response. CM Fryman made a motion for Stutler's. Seconded by CM Craig. Motion carried. TM Turner & CT Stevens will decide which fund to pay it out of.
- o Clarifier work is finished.
- o Eric Graver passed all 4 tests that is required for the sewer plant.
- Best Way is increasing per ton of the dumpsters at the sewer plant for the sewer sludge. Bauer stated he figured \$780.00 per bag of sludge. 6 bags per year. Bauer did state Rumpke does not provide this service to Dillsboro.
- Pump Station #2 needs a pump replacement. Fixing it the quote is \$8,201.64. New replacement is \$7,971.00. CM Benning made a motion to purchase a new pump. Seconded by CM Caldwell. Motion carried. This to be paid from sewer.
- New mower replacement. Zimmer's has a Kubota Z-D 1211 mower for \$16,982.00. Bauer stated having problems with 2 mowers. CM Fryman made a motion to purchase this mower.
  Seconded by CM Benning. Motion carried. Mower will be paid from Riverboat.

### Beautification - Charlie Caldwell

Caldwell stated needs more flower pots for 2024. Asking businesses to sponsor a flower pot and pay for it. Looking at using a whiskey barrel. Bauer stated he would recommend spraying the inside of it. Caldwell stated J & J Liquor has one and they have a cut down metal garbage can inside of it. Will possible do something like that. Council has no problems with Caldwell's suggestions and stated the flowers pots looks great around town.

## Parks - Kevin Turner

 Park Board voted to have restrooms at the baseball fields closed due to vandalism unless a event is going on. Will be closed August 1, 2023. O Park Board voted to purchase rubberized mulch from St. Johns School that was left over from their playground project for \$2,700.00. Then Dillsboro School is donating their mulch from a leftover project. Park Board voted to purchase up to \$9,200.00 for the rest of the mulch that is needed.

# Legal - John Watson

Dearborn County Regional Sewer District Board, Town of Dillsboro (Matt Bauer & Kevin Turner), Lori Young and Attorney Watson held a meeting on July 18 regarding the Lake Dilldear Sewer Project. Watson stated need to contact Bob Reynolds, LWG, and get a base rate and go from there. CM Benning made a motion to pay Reynolds up to \$5,000.00 for his financial services and be paid from sewer. Seconded by CM Craig. Motion carried. Watson also suggested to have a Executive Meeting on August 14<sup>th</sup> at 5:30 p.m. prior to the regular council meeting to discuss the Lake Dilldear Sewer Project. TM Turner will contact Reynolds. CT Stevens stated maybe TM Turner and CM Benning could set up a meeting at the AIM Summit with Reynolds if needed.

CM Baker asked if anything going on with the Art Center regarding the lawsuit. Watson stated nothing new.

### **New Business**

CM Baker stated for council to think about meeting once a month starting in 2024.

CM Baker also stated he has Sunflowers at his house. Thinking about if people wants to use them as a background in a picture they could make a donation to the Dillsboro Playground Fund. CM Baker asked CT Stevens if people could drop the check at the Utility Office. CT Stevens has no problem with this.
