### DEFINITION OF PLANNING AREA

The planning area includes the Town of Dillsboro, Clay Township, and Caesar Creek Township, hereinafter referred to as the "Community".

### NATURAL FEATURES & LANDSCAPE

Each of the parks serve not only the town of Dillsboro, but the rest of Clay Township and neighboring Caesar Creek Township as well.

The parks have most of the same natural features as the surrounding area, which is relatively flat with only some rolling areas on the northwest end around the current soccer fields within the Community Park. The soil is clay based and not the easiest to work with but no significant barriers to prohibit maintaining grass playing surfaces or shrubs, trees, bushes, or grass in the recreational areas. The clay soil does not drain particularly well. Much work has been done on the "dirt" areas of the ball fields so that they drain well and are almost always playable. The grass area drainage can be improved.

Maple, Oak, and Cedar trees are most predominant within the park and surrounding area. There was once a good concentration of ash as well but those have been removed with the Emerald Ash Borer threats of a few years ago. Many trees have been taken down and the shade is not as plentiful as it once was but there are still trees providing shade for spectators on 2 of the 4 baseball/softball fields with some smaller trees planted for another field. Once plans are set for the upgrades on field #4, there will be trees planted around that field as well. One of the compliments Dillsboro Summer Ball gets every summer is that there is plenty of shade and comfort for spectators compared to many of the fields for local competitors.

There are two areas of the Community Park that can still be developed, and trees and landscaping can come into play on both. Depending on how they are used, drainage can be a factor and a possible expense. Different ideas have been thrown around toward how to use the grass area down by Field #4 and still allow drainage and runoff from that field in particular. The other parks are undeveloped, with potential for trees and other landscaping.

We have sought the advice of 2 local resources and their advice and connections could be a great help moving forward with any plans. Jeff Hermesh is our Purdue Extension agent for Dearborn County. Doug Berger is a retired park superintendent in Butler County, Ohio. He and Jeff both walked the grounds with us and provided some good input toward what may work in improving and utilizing the park. Both have volunteered their input and resources moving forward.

### MAN-MADE, HISTORICAL, & CULTURAL

A local 1855 newspaper states, "Dillsborough is noted for roads – there being no less than 7 or 8 public roads crossing or terminating at this place." These same roads still connect Dillsboro to the surrounding farming areas, towns, and cities. One, a major east-west road, became U.S. Hwy 50. In 1855, the Baltimore and Ohio rail lines ran close to town and Dillsboro became known as the 2<sup>nd</sup> best business on the railroad, running between Cincinnati and St. Louis. Over time, the trains no longer stopped, and U.S. 50 became a 4-lane highway which bypassed our town.

One of our parks, Heritage Pointe, is centrally located in town where many of these roads crossed; thus, its name. This pocket park is where the Farmer's Market, Veteran's Day observances, town sponsored events and nearby Dillsboro Arts outdoor events take place.

The Dillsboro Oil and Gas Company, in 1900, found neither oil nor gas but did uncover an inexhaustible stratum of mineral water which showed qualities of medicinal value. The Dillsboro Sanitarium Company was incorporated in 1922. People visited to take advantage of the "healing waters" until the 1950's. Today, this area is a nursing home complex, but along one side, a small historical park is located - Sanitarium Well #2, which was a source of White Crane mineral water used at the historic Dillsboro Sanitarium health Resort. This Bicentennial Legacy Project area was gifted to the town by St. Elizabeth Medical Center in 2016. A small shelter house covers the original pump and two picnic tables.

Streets, sidewalks, and curbs through most of the downtown are in good condition, but improvements to all three need to be made in other sections of the town. Dillsboro recently took advantage of a \$20,000 planning grant for Community-wide Bicycle and Pedestrian Improvements, which was completed in March 2023. This plan was supported by funds made available from the Centers for Disease Control and Prevention (CDC), Center for State, Tribal, Local and Territorial Support, under NH75OT000073-01-00, administered by the Indiana Department of Health, Division of Nutrition and Physical Activity. The contents of this plan are those of the authors and do not necessarily represent the official position of or endorsement by the CDC. This plan was accepted as part of the Town Comprehensive Plan and will be the guide towards future improvements in connecting our existing trails and providing safe passage from all sections of town to our schools, preschools, business area, churches, and parks.

In 2016, the Dillsboro Heritage Festival was started. Every year, a different historical theme is displayed. This event has evolved to now include a historical scavenger hunt, pioneer games and activities for the youth, a car show, a baseball scrimmage, homemade ice cream, outdoor concert, and a Veterans' Walk which displays information about the veterans from our area. These events are held at the Civic Center, the Community Park, Heritage Pointe, and at the park that is known as the "green space".

Presently, there are no nighttime recreation options offered at three of our parks since there is no outdoor lighting; they are open from dawn to dusk. The "green space" does have several strands of overhead lights utilized whenever there is a concert or when the Veteran's walk is on display.

If an organized event is happening in Dillsboro, it usually takes place in one of our parks or spread out to encompass several park sites. The Community Park and Heritage Pointe can be rented by individuals or organizations for special events.

From the 2010 to 2020 census, the total population decreased by 1.5%. While Dillsboro and Caesar Creek Township's populations increased by 33 and 19, respectively, Clay Township's population decreased by 122. It is important for Dillsboro to invest in amenities that will positively impact the quality of life of its residents and attract new residents, businesses, and revenue streams. However, the ability to raise local match, manage/afford reimbursement-based grants and the ability to adequately sustain any new amenities must be considered ahead of any new endeavor and revenue-generating projects must be prioritized. Dillsboro is fortunate to have various foundations and other sources of local match that may be willing to support various efforts.

The Town of Dillsboro has supported these parks through tax-based appropriations and very limited revenue from shelter rentals. However, their upkeep has become a strain on the Town's budget and grants and/or additional sources of revenue would be needed for additional improvements.

The only other public recreational areas in the Community are the gym and playground at Dillsboro Elementary School.

### ACCESSIBILITY & UNIVERSAL DESIGN

At the Dillsboro Community Park, all sidewalks leading to the park have ADA ramps. The southern/baseball side provides accessibility to the parking area, concession area, walking trail, and three of the four baseball diamonds; all interconnected. It lacks accessibility to the playground, swings, and gaga ball arena. The number of handicapped parking spaces meets the requirement and the spaces are striped and have signage. The northern/soccer side of the park provides accessibility to the parking area, concession area, restrooms, walking trail, and the playground, as well as visibility to most of the playing fields; all interconnected While the playground was designed to be accessible, there is need to replace the current mulch surfacing. The number of handicapped parking spaces meets the requirement, and the spaces are striped and have signage. The northern and southern sides are also connected by an accessible path. The park is open to the public from dawn until

dusk and is also utilized by several community organizations and programs (SAY Soccer, Dillsboro Summer Ball, Munch-A-Lunch, etc.) as well as informal groups who gather to play Ultimate Frisbee, for example.

At Heritage Pointe, there is no parking within the park itself. The parking lot between Heritage Pointe and Friendship Gallery has parking with ADA accessibility to Heritage Pointe. There are a few street parking areas, which are adjacent to the sidewalks surrounding the Pointe's paved surface, which are not marked or striped for the handicapped. There is a parking lot across the street that does have handicapped parking spots available; however, it is not specifically part of the park. There are no amenities at this park.

The North Street Park and Well #2 do not have any amenities at this time, nor do they have any internal sidewalks or parking. There is parking adjacent to both areas, but not within the parks themselves. The North Street Park is a grassy area, known as "The Green Space", often utilized for craft fairs, concerts, holiday decorations, and the Veteran's Walk.

Presently, the public is not being notified about ADA's nondiscriminatory requirements; nor are there any accessibility facilities, programs, or services. Notices and flyers could be displayed on the south side in the enclosed bulletin board mounted in the concession area. An additional enclosed bulletin board would be needed for the other end of the park; it could be mounted near the north side concession area.

### PUBLIC PARTICIPATION

To ensure input was gathered from as many Community members as possible, one random public input method (a survey) and one non-random method (a public meeting) were conducted.

### Survey Information

Survey Type: Electronic (via QuestionPro) and Hard Copy (See ATTACHMENT A)

Survey Date Range: April to October, 2022

**Advertising Methods:** Town Newsletter, Facebook Posts, School News Bulletin, Church Bulletins, Mass Emails, and Flyers (with QR codes) posted at local businesses, apartment complexes (including low income and senior housing), and the Dillsboro Community Park. Hard copies were distributed at Baseball Opening Day and other community events.

**Responses:** 135 surveys were completed and an additional 38 were started/incomplete. Demographic data showed that survey respondents included males & females, an age range from <21 to 91+, multiple ethnicities, and households of 1-6+. 87% of respondents were residents of Dillsboro, Clay Township or Caesar Creek Township. 89% had visited at least one of the parks in the last year. 10% had experienced a barrier to accessing the parks, such as lack of sidewalks, ramps, etc.

**Comments & Issues Discussed:** Suggestions ranged from new or upgraded facilities and amenities to maintenance and landscaping to activities.

Attendance: Fifteen members of the public attended the meeting.

**Comments & Issues Discussed:** Attendees were shown a PowerPoint presentation, detailing the purpose and results of the Dillsboro Community Park Survey. They were encouraged to share any additional ideas for our parks, which resulted in two additional suggestions; a Ninja Warrior course and historical information being placed along walking trails.

The suggestions from the Dillsboro Community Park Survey and the two new suggestions were displayed on easels around the room. Attendees were each given six stickers and asked to vote for their top five suggestions and to place a star next to their top "wish list" suggestion.

This meeting also served as an opportunity to ask community members if they would be interested in serving on Dillsboro's Park & Recreation Board.

### Top 5 Most Common Needs or Desires Expressed by the Park Board/Advisory Committee:

Members felt it was important to prioritize safety and accessibility as well as anything that could potentially lead to greater use of the parks and revenue generation. They also recognized that there are a couple of relatively inexpensive "low hanging fruit" items that are important to the public and should be prioritized.

1. Playground/Amenities – Discussed ideas such as equipment, inclusive of children and adults of all ages and abilities, frisbee golf, exercise stations, etc. Agreed with the public's expressed need for a dog park, as community members currently close the gates to the baseball fields and let their dogs run, dig, and relieve themselves on the field, causing damage to the fields as well as sanitation and health concerns.

- 2. Safety/Accessibility Additional mulch, relocation or removal of the swings at the Community Park, and a paved pathway to the bathrooms on the baseball side of the park are needed to ensure safety/ADA compliance. Moving the basketball goal from its current location near the parking lot would decrease safety concerns; could potentially put in a court by the soccer fields that would also double as a pickleball court (as its increasing in popularity). Other concerns/ideas included nets to avoid injury from foul balls (which are frequently landing in the spectator area), picnic tables with wheelchair accessibility, an area for wheelchair users to more easily view games, pathways and ramps, a loud speaker system, lightning detection system, signage, etc.
- 3. Increased Parking at the Community Park This would allow for larger tournaments; a potential increased revenue stream.
- 4. A Stage at "The Green Space" A permanent stage, ideally including bathrooms, may increase interest and feasibility of regular concerts, events, etc. and could bring in additional revenue.
- 5. Bike/Walking Pathways Would like to see improvements to existing and increased pathways that extend beyond the Community Park to other parks/areas of the community.

**Dream Project:** As there was such high public interest in a pool or splashpad, pros/cons of each were weighed and members felt that a small splash pad would be a more realistic dream project, as it would be less costly and easier to maintain. Estimated costs of a splash pad is \$100,000.

### Dillsboro Parks Community Survey

Dillsboro's Park Advisory Board would like input from residents of all ages and abilities to help in the creation of an inclusive strategic plan that adequately represents the interests of its community members. The following four parks will be addressed in the plan:




