## December 11, 2023

The regular meeting of the Dillsboro Town Council was opened by President, Doug Baker, with the pledge to the flag on December 11, 2023 at 6:10 p.m. After the Public Hearing of the Dillsboro Parks and Recreation 5-Year Master Park Plan.

Council members present: Doug Baker, Becky Fryman, Tim Benning and Charlie Caldwell. Council member absent: Jerri Jackson. Attorney present: John Watson.

The council minutes of the Regular Meeting on November 27, 2023. CM Benning made a motion to approve the minutes. Seconded by CM Fryman. Motion carried.

#### Clerk-Treasurer - Rita Stevens

- McPherson Property Listed for \$89,900. Original building is downtown commercial. Front should be a store front. Living quarters in the back. It has been an apartment building.
- O Wagner Property Listed for \$2,200,000 for 109 acres.




